Outside Plan Check Consultants

The Escondido Fire Department requires the following fire protection systems and designs be submitted for third party review for the *initial* plan check. The fire protection system types are as follows:

Fire Protection Systems: Approved devices, equipment and systems or combination of systems used to detect a fire, activate an alarm, extinguish or control a fire or any combination thereof, i.e.

- Fire Sprinkler Systems, all NFPA 13,13D,13R systems
- Fire Sprinkler TI's, 6 or more heads
- All Fire Alarm Systems
- Underground Fire Lines
- Commercial Kitchen Cooking Systems, Standpipe systems
- FM200 Systems
